



**Practice Incentives Program
eHealth Incentive
Application Form**

The Practice Incentives Program (PIP) eHealth Incentive aims to encourage practices to keep up to date with the latest developments in eHealth.

Eligibility

To be eligible for the PIP eHealth Incentive, your practice must:

- participate in the PIP;
- have a secure messaging capability, which is provided by an eligible supplier;
- have (or have applied for) a location/site Public Key Infrastructure (PKI) certificate for the practice and each practice branch, and ensure that each medical practitioner working at the practice has (or has applied for) an individual PKI certificate; and
- provide practitioners from the practice with access to a range of key electronic clinical resources.

Requirement 1 – Secure messaging capability

Locums are exempt from this requirement. To maintain compliance with this requirement, new practitioners must apply to Medicare Australia for an individual PKI certificate within 14 calendar days of joining the practice.
